- 2. Public Forum Jean Waltz BSDVT School Board Commissioner Thanks to City Clrs for acknowledging motion that School Board considered on the subject of SROs, for recognizing the importance of continued consideration of the position of SROs and Pilot funds.
- 3. Committee name change Dir Green spoke to reasoning behind suggested name change. Discussion. Proposed name change to "Racial Equity, Inclusion, and Belonging Committee", Change supported by all members of the committee. Clr Dieng to contact CAO for guidance on process for name change.

Item 4.0 Outreach Report to Education Institutions. Welcome to Sandy Yusen (SY) from Champlain College, Director of Communications and External Relations. Sandy suggested that the Committee also connect with Nadia Mitchell, Equity Initiatives Director. Champlain College has committed to the following - Strategic review of DE&I priorities, with goals and benchmarks. Review of organizational practices, including a collegewide audit and opportunities for short and long-term priorities Clr Paul - Recognize that Champlain College has great resources for the City and is a great neighbor – welcomes areas for collaboration Clr Pine – Supports engagement with the engage with community in a meaningful way on this issue, including scholarship funds and other engagement – with Champlain College and UVM Clr Dieng – What is current collaboration with City? (SY) President Akande has met with Mayor Weinberger and taken part in recent COVID related press briefings to announce discounted rate Champlain College online courses, designed to help those changing career path, as a result of pandemic and related economic situation. Clr Pine will connect with UVM to request representation at the next meeting, to hear of UVM's work to support the advance of racial justice work in the community and expanding partnerships to address issues

Item 4.1 Follow up to the Racial Justice Resolution. Clr Pine – would like to give consideration to upcoming resolutions to City Council on BTV's role around chattel slavery and how do we as a city move forward on reparations? Invites Dir. Green to speak on the context and background for this work and any information to hand on the approach of other cities to

the question. Dir Green – reviewed the progress of H40 and its relevance to reparations discourse. Talked about the importance of considering what happened in VT, our role in perpetuating slavery, and the potential for subsequent racial reckoning and awakening. Reviewed the experience of action in other cities, including Asheville, NC and the types of reperations pathways that might be available.

Clr Pine talked to a proposed resolution on Reparation coming to City Council.

Clr Dieng suggests that the committee invites Mary Danko, Director Fletcher Free Library to following meeting to hear about the racial equity work of the Foundation.

Clr Dieng notes the work of Clr Pine on the removal of ELAP mural and Clr Paul on the installation of the BLM mural

Clr Paul talked to the BLM mural process and reported on the PAC meeting and the BCA and Church St Marketplace next steps on ELAP
