NARRATIVE:

This morning Burlington Police along with agents from Alcohol, Tobacco, and Firearms, United States Marshals, Drug Enforcement Agency, and Immigrations and Customs Enforcement, South Burlington Police Department and Colchester Police Department conducted three simultaneous search warrants within the city of Burlington.

The warrants are part of a two month long narcotics distribution investigation conducted by the Burlington Police Department. Police searched residences located on Murray Street near Peru Street, Grant Street near North Union Street, and Converse Court.

Police seized cocaine, cash and a loaded firearm during the execution of the warrants. Police also arrested the following individuals;

William Hylton age 26 of Manhattan New York Leon Delima age 25 of Burlington Vermont Evelyn Ingram age 19 of Burlington, Vermont Mitch White age 51 of Burlington VT All four individuals have been charged with Felony Sale of Cocaine. The investigation by




