Shaun M. Lacross was lodged at Chittenden Regional Correctional Facility on a Warrant for Escape held without bail, he will be charged with Simple Assault/ Resisting Arrest/ Endangering the Welfare of a Child and arraigned at a later date.

Amber Fusco was issued a citation to appear in court on a later date and will be charged with Domestic Assault (Misd)/ Endangering the Welfare of a Child/ Harboring a Fugitive NARRATIVE:

On June 21/2017 the Burlington Police Department responded to 49 Archibald Street, to a reported assault that had occurred. The victim indicated he had been assaulted by two subjects, identified as Shaun M. Lacross 10/21/87 and an Amber R. Fusco 7/15/88. The victim sustained injuries to his face consisting of scratches and lacerations. Officers attempted to make contact with Lacross and Fusco but they refused to answer the door. During the investigation it was learned that Lacross was currently wanted out of the State of Vermont for Escape status from the Vermont Department of Corrections.

Burlington Police were granted a search warrant and executed it at 49 Archibald taking both Lacross and Fusco into custody. During his arrest, Lacross actively resisted his arrest. Through subsequent interviews it was learned that a 2 yr old child was present during the assault earlier but was unharmed. The victim did not need medical attention.
