Mayor Miro Weinberger Appoints Jesse Bridges as New Department of Parks and Recreation Director

Burlington, VT – Mayor Miro Weinberger today announced the appointment of Jesse Bridges as the new Director of the Department of Parks and Recreation for the City of Burlington. Bridges currently works at the University of Vermont Foundation as the Associate Director of Major Gifts for Athletics and as an Assistant Athletic Director for the UVM Athletic Department, where he has worked for more than 10 years. Weinberger has asked the City Council to approve the appointment at its October 15, 2012 meeting.

“The City of Burlington will be very fortunate to have a leader, team player, and motivator like Jesse Bridges serve as our Parks and Recreation Director,” said Weinberger at a press conference held at the Robert Miller Community and Recreation Center. “Jesse has a thirst for challenges and a track record of success at each professional challenge he has taken on. His leadership and management roles, revenue raising skills, and extensive budgeting experience will serve our City well.”

In addition to his UVM work experience, Bridges earned both his Bachelor of Arts and Master of Public Administration degrees at UVM. While at UVM, both as a student and a professional, Bridges has won awards and been honored, including his induction into the International Honor Society of Public Administration and his designation on three occasions as a Department of Athletics staff award winner.

“I look forward to bringing a new perspective and energy to lead the Department during a promising and innovative time and to enhance the quality of life for our community members,” said Bridges. “I appreciate the Mayor’s and Parks and Recreation Commission’s confidence in my abilities to take Parks and Recreation to the next level and am excited and honored to be joining Burlington’s leadership team and the dedicated staff at the Department of Parks and Recreation.”

MEMORANDUM

To: City Councilors

Re: Appointment of Director of Department of Parks and Recreation

I respectfully submit for your consideration and approval Jesse Bridges as the next Director of the Department of Parks and Recreation. I am requesting City Council approval of this appointment at your October 15, 2012 meeting.

Jesse has emerged as the top candidate after a thorough process that included:

- Advertising nationally for the position, including targeting of diverse communities and supplemental recruitment efforts by my office;
- Review of resumes and initial interviews by a five-person search team led by Assistant to the Mayor Carina Driscoll, and including Councilor Dave Hartnett and Parks and Recreation Commissioners Carolyn Hanson, John Bossange, and John Ewing. This team reviewed resumes, conducted interviews and ultimately advanced six finalist candidates for my consideration;
- Four separate Parks and Recreation department meetings where I solicited input regarding the director position and the future needs of the department from nearly every full-time Parks and Recreation employee;
- Finalist interviews with a group of stakeholders that included representative employees and community partners.

Jesse is an excellent candidate for this position for numerous reasons, including his:

- **Experience on the leadership team of the University of Vermont Athletics Department and Foundation.** Jesse has served in a number of UVM roles that have given him broad management experience in budget development and management,

fundraising and revenue generation, and strategic planning. I encourage you to read the attached thoughtful July 27, 2012 letter from Jesse to me where he expands on this.

- **Track record of rising to each new professional challenge before him.** Jesse has succeeded in a broad array of UVM roles since 1998. He has steadily taken on increasing responsibility in his time at UVM, creating new challenges for himself and finding success in those challenges. He has won multiple staff awards from UVM and will come to the City with very high recommendations from senior administrators at the University.
- **Commitment to Public Service and Community.** I am impressed that Jesse attained a Master of Public Administration from UVM in 2008 while also working full time, and that this academic work resulted in induction into the International Honor Society for Public Administration (in addition to his numerous prior academic honors). Also, while at UVM, Jesse participated in Leadership Champlain. After completing the program he became a member of the Leadership Champlain Board and helped plan the Government and Politics, and the Cultural Competency days that are part of the Leadership Champlain training.
- **Fundraising and Revenue Generation.** Much of Jesse's focus at UVM has been on revenue generation, and in recent years, fundraising. Jesse has achieved considerable success generating revenues and gifts and this experience will be invaluable for a department that is responsible for generating much of its revenue internally, and is seeking to create a new foundation as an additional supplement to revenues.
- **Commitment to Athletics, Recreation and Burlington.** After graduating from the University of Vermont, Jesse committed his working life to the UVM Athletics Department for the next ten years. His roles at UVM were focused on high-level varsity athletics, but also involved planning and leadership duties related to club and intramural recreation. At UVM he has built on his passion for the role of athletics in our lives and in our community, and he wants to bring that passion to our Burlington Parks and Recreation Department and our community.

Further details of Jesse's background can be found in his attached letter and resume.

If confirmed, Jesse plans to begin his work for the City on Monday, October 22. While Mari Steinbach's last day in the office will be this Friday, October 5, she has agreed to be available to the new director during the early weeks of new leadership. I am grateful to Mari for her continued service to Burlington through this transition period.

Thank you for your consideration of Jesse Bridges as the next Burlington Director of Parks and Recreation.

Dear Mayor Weinberger,

Please accept my application for Director of Parks and Recreation for the City of Burlington. With over ten years of progressive responsibility in multiple avenues of administration and a substantial background in organized physical activity, I believe I am uniquely positioned to lead this department into the future. With an extensive network and a positive reputation within the Burlington community, I would bring the ability to engage constituents of all ages in the experience and decision making process surrounding the direction of our community spaces and activities.

Budget Development and Management

As a member of the University of Vermont's Budget, Finance and Investment Committee and the Athletic Department's Budget and Finance Sub-Committee, I have managed multiple budgets and participated in the development of budgets at differing levels of complexity from university wide down to individual programs. In addition, each year I have participated in multiple audits, both internal and external, of revenues and business processes giving me a detailed understanding and appreciation for how the budget can manage and inform our operations. The budget is not only a means for managing finances, it is the fundamental driver of strategic policy development. We have a responsibility to make sure that money spent on Parks and Recreation is not only done with the public's input but also with the public's trust. A transparent and zero based budgeting process would accomplish this goal.

Fundraising and Revenue Generation

Since I started at the University of Vermont in 2002, the Athletic Department has seen increased revenues and decreased operating expenses in all administrative units. My skills, in this area, focus on philanthropic fundraising, outbound sales, and revenue forecasting. With much of the Parks and Recreation funding coming from internally generated revenues the next Director needs to be able to focus on improving those areas to limit any burden on the general fund. Through thoughtful partnerships with private corporations, individuals, and local/state entities we can continue to develop a Parks and Recreation system of envy around the country. We can do more with the focus

on private philanthropy and, as the Director, I would take charge of the efforts surrounding the new Parks Foundation. Just think of the publicity when Burlington hosts the X Games on the waterfront at the new Burton Skate Park.

Strategic Planning and Leadership

Over the past ten years I have been part of multiple long term strategic planning processes. Through the development of core values, strong mission/vision and both short term and long term goals the Athletic Department, University and Foundation have moved to new heights. This process has been led at senior management level but has been driven by the decisions and goals of the employees. I would bring this collaborative leadership style to the Department. Parks and Recreation has many outstanding staff, teachers and professionals who, when engaged in the process of setting the future course, would be exponentially more productive and have a higher personal satisfaction with their work. I encourage independent decision making not only with my direct reports but through the work of others across the organization and outside with volunteers.


Recreation
