AFFAIRS SPECIALIST to be eliminated and replaced with a Non-Classified position of  
DIVISION MANAGER OF GOVERNMENT AND REGULATORY AFFAIRS based on the  
increased responsibilities of the position and the reorganization of the department; and

WHEREAS, the General Manager of Burlington Telecom has requested the Non-  
classified position of INFORMATION SERVICES ADMINISTRATOR to be eliminated and  
replaced with a Non-Classified position of DIVISION MANAGER OF BUSINESS OFFICE  
based on the increased responsibilities of the position and the reorganization of the department;
