15 Resolved by the City Council of the City of Burlington, as follows:

17 That WHEREAS, the City of Burlington ("City") owns and operates the Burlington

18 International Airport, located in South Burlington, Vermont ("Airport"); and

19 WHEREAS, the Director of Aviation at the Airport has negotiated with Greyhound Lines,  
20 Inc., a Delaware Corporation providing public/commercial bus transportation ("Greyhound"), an  
21 agreement by which Greyhound will lease office/counter space in the Airport's Terminal and  
22 parking near the Terminal in order to provide bus services to and from the Airport, in the interests  
23 of the traveling public and public airport purposes ("Agreement"); and

24 WHEREAS, the Director of Aviation has determined that the Agreement will be a  
25 reasonable revenue source for the City;

26 NOW, THEREFORE, BE IT RESOLVED that that upon the April 12, 2010, approval of  
27 the Board of Finance, Mayor Bob Kiss be and hereby is authorized to execute the Agreement and  
28 any other documents necessary in order to facilitate said Agreement on behalf of the City, subject  
29 to the prior review of the City's Chief Administrative Officer and the City's legal counsel, as  
30 necessary.
