AUTHORIZATION TO CONTRACT FOR SERVICES ASSOCIATED WITH ESCALATOR REPLACEMENT PROJECT AT BURLINGTON INTERNATIONAL AIRPORT

CITY OF BURLINGTON

In the year Two Thousand Ten.....

Resolved by the City Council of the City of Burlington, as follows:

That WHEREAS, the City of Burlington ("City") owns and operates the Burlington International Airport ("Airport"); and

WHEREAS, the Airport's Director of Aviation has determined that it is necessary to replace the main terminal escalator and that it will be in the best interest of the City, the traveling public and public airport purposes to do so; and

WHEREAS, the Director of Aviation has determined to contract with Schindler Elevator Corporation for services related to replacing older, less reliable escalators at the Airport terminal with more modern, safe and more cost effective escalators, with a contract in the amount of Two Hundred and Six Thousand Dollars (\$206,000.00) (the Agreement), to be paid for with Airport operating revenues which are planned to be reimbursed with PFC funding,

NOW THEREFORE BE IT RESOLVED THAT the Director of Aviation, Brian Searles, be and hereby is authorized to negotiate and execute the Agreement and any documents necessary to facilitate the Agreement, subject to any applicable City Purchasing Procedure and to prior review by the Chief Administrative Officer and the City Attorney as appropriate.
