15 Resolved by the City Council of the City of Burlington, as follows:

17 That WHEREAS, the City of Burlington Annual City Election Meeting occurs on  
18 March 1, 2011; and

19 WHEREAS, Julia Curry, Ward Clerk for Ward Three, will be out of state for work on  
20 March 1, 2011; and

21 WHEREAS, Julia Curry, Ward Clerk for Ward Three, has requested Damon Lane,  
22 elected Ward Three Inspector of Election, be appointed to serve as Acting Ward Three Ward  
23 Clerk for the Annual City Election Meeting that will be held on March 1, 2011; and

24 WHEREAS, Julia Curry, Ward Clerk for Ward Three, has requested Sara Jelen to be  
25 appointed to serve as Acting Ward Three Inspector of Election (Damon Lane's elected role); and

26 WHEREAS, Marlene Phillips, Inspector of Election for Ward Two, will be unavailable to  
27 work on March 1, 2011; and

28 WHEREAS, Wendy Coe, Ward Clerk for Ward Two, has requested that Jean Berthiaume  
29 be appointed to serve as Acting Ward Two Inspector of Election for the Annual City Election  
30 Meeting that will be held on March 1, 2011; and

31 WHEREAS, Jim Couture, Ward Clerk for Ward Four, has requested that Bill McNamara  
32 be appointed to serve as Acting Inspector of Election (due to Lee Gilbert, appointed Inspector of  
33 Election being able only to work the first part of the day due to health-related reasons) for the  
34 Annual City Election Meeting that will be held on March 1, 2011; and

42 of ward clerk and inspectors of election, when the vacancies occur due to an inability to serve,  
43 pursuant to City Charter §13, as will happen in this circumstance;

45 appointments of Damon Lane (P) as the Acting Ward Clerk for Ward Three; Jean Berthiaume (D) as the  
46 Acting Inspector of Election for Ward Two; and Bill McNamara (I) as the Acting Inspector of Election  
47 for Ward Four for the March 1, 2011 Annual City Election Meeting.
