15 Resolved by the City Council of the City of Burlington, as follows:

17 That WHEREAS, the City of Burlington has worked with the Chittenden County Regional  
18 Planning Commission to identify hazards, analyze past and potential future damages due to all  
19 hazards and identify strategies for mitigating future damages; and

20 WHEREAS, the City of Burlington All-Hazards Mitigation Plan (Annex 3 of the  
21 Chittenden County Multi-Jurisdictional All-Hazards Mitigation Plan) in Sections I, II, III and IV  
22 analyzes hazards and assesses risks in the City; and in Section V recommends the  
23 implementation of a variety of actions to mitigate against damage from hazard events; and

24 WHEREAS, drafts of both the Chittenden County Multi-Jurisdictional All-Hazards  
25 Mitigation Plan and Annex, the City of Burlington All-Hazards Mitigation Plan were made  
26 available for review by the public and the municipality prior to consideration of this resolution;  
27 and

28 WHEREAS, a duly-noticed public meeting was held by the City of Burlington City  
29 Council to formally consider adoption of the Chittenden County Multi-Jurisdictional All-Hazards  
30 Mitigation Plan and Annex 3, the City of Burlington All-Hazards Mitigation Plan;

31 NOW, THEREFORE BE IT RESOLVED that the City of Burlington adopts the  
32 Chittenden County Multi-Jurisdictional All-Hazards Mitigation Plan and Annex 3, the City of  
33 Burlington All-Hazards Mitigation Plan; and
