15 Resolved by the City Council of the City of Burlington, as follows:

17 Pursuant to Sec. 62 of the City Charter, the Chief Administrative Officer be and hereby is  
18 authorized to:

19 1. Pledge the credit of the City by temporary loan in anticipation of the receipt of  
20 revenue from the Water Resources Division of the Department of Public Works for the Fiscal  
21 Year ending June 30, 2012, such temporary loan not to exceed \$1.0 Million; and

22 2. Pledge the credit of the City by temporary loan in anticipation of revenue from the  
23 Wastewater Division of the Department of Public Works for the Fiscal Year ending June 30,  
24 2012, such temporary loan not to exceed \$1.0 Million; and

25 3. Pledge the credit of the City by temporary loan in anticipation of revenue from the  
26 Traffic Division of the Department of Public Works for the Fiscal Year ending June 30, 2012,  
27 such temporary loan not to exceed \$1.0 Million; and

28 BE IT FURTHER RESOLVED that pursuant to Sec. 62 of the City Charter, the Chief  
29 Administrative Officer be and hereby is authorized to pledge the credit of the City by temporary  
30 loan in anticipation of the receipt of revenue from the Airport Department for the Fiscal Year  
31 ending June 30, 2012, such temporary loan not to exceed \$5.0 Million; and

39 BE IT FURTHER RESOLVED that pursuant to Section 62 of the City Charter, the Chief  
40 Administrative Officer be and hereby is authorized to pledge the credit of the City by temporary  
41 loan in anticipation of revenue from the Burlington Electric Department for the Fiscal Year  
42 ending June 30, 2012, such temporary loan not to exceed \$5.0 million; and

43 BE IT FURTHER RESOLVED that such loan or loans in anticipation of the receipt of  
44 revenue from the Water Resources Division, Wastewater Division, and Traffic Division of the  
45 Department of Public Works, the Burlington International Airport Department, and the  
46 Burlington Electric Department shall be utilized to pay for their ordinary running expenses when  
47 there are not sufficient funds on hand to the credit of the Water, Wastewater or Traffic Divisions  
48 of the Public Works Department, the Airport Department or the Burlington Electric Department,  
49 respectively, for the payment of such bills and accounts, such loan or loans to be repaid from  
50 revenues received by such Divisions or Departments; and

51 BE IT FURTHER RESOLVED that such loan or loans may be utilized to refund or  
52 redeem or pay at maturity outstanding loans or notes of the City incurred for the same purpose of  
53 paying the ordinary running expenses of such Department or Departments.
