17 That WHEREAS, the recently revised Vehicle for Hire Ordinance provides that in the future
18 taxi and contract vehicle related administrative fees shall be recommended by the Taxi Licensing
19 Board and approved by the City Council; and

20 WHEREAS, there is insufficient time to establish a Taxi Licensing Board to recommend
21 fees before the upcoming taxi licensing season begins; and

22 WHEREAS, the Ordinance Committee has reviewed and adjusted the current fees as a
23 part of its work on the revised Vehicle for Hire Ordinance; and

24 WHEREAS, for this initial licensing season under the revised Vehicle for Hire
25 Ordinance, the Ordinance Committee shall make the following recommendations for the taxi and
26 contract vehicle related administrative fees for approval by the City Council;
