SUSPECT DISPOSITION:			

Following the execution of a search warrant at a residence on N Willard St. in Burlington, VT Burlington Police Department Detectives arrested Elaine Williams, Vanessa Davis, Albert Johnson Jr., Richard Heath, and Tracy Crawford all of Burlington, VT. Williams, Davis, and Johnson were transported to Chittenden Superior Court — Criminal Division in Burlington for arraignment. Heath and Crawford were released on citations to appear in court on a later date for their charges.

NARRATIVE:

On the morning of July 13, 2018, Burlington Police Department Detectives arrested Elaine Williams, Vanessa Davis, Albert Johnson Jr., Richard Heath, and Tracy Crawford after executing a search warrant at a residence on N Willard St in Burlington, VT.

Detectives obtained the search warrant following a BPD drug investigation that lasted several months and involved collaboration with the Drug Enforcement Administration (DEA). During the warrant execution, investigators seized over an ounce and a half of "crack" cocaine, heroin, and over \$6,000 in US currency. The "street value" of the recovered "crack" cocaine is approximately \$10,000.

- Elaine Williams was charged with Sale of Heroin (2 counts), Sale of Cocaine, Possession of Cocaine, Possession of a Narcotic, and Violation of Court Conditions of Release.
- Vanessa Davis was charged with Sale of Heroin, Possession of Cocaine, and Possession
 of Heroin. Davis has a lengthy criminal history including prior convictions for drug sales
 and had several outstanding warrants at the time of her arrest.
- Albert Johnson Jr was charged with Possession of Cocaine and Possession of Heroin.
 Johnson Jr. has previous federal convictions for drug trafficking and is currently on
 supervised release with the United States Probation Office for drug distribution
 offenses.
- Richard Heath was charged with Possession of Cocaine.
- Tracy Crawford was charged with Possession of Heroin. Crawford has a lengthy criminal history out of Vermont and New York including convictions for drug trafficking.
