On March 9th, 2019, the Chittenden Unit for Special Investigations (CUSI) was contacted by the Burlington Police Department regarding a report of a Sexual Assault. On March 10, 2019, as a result of the investigation Kerry J. Schunk was arrested at his residence in Burlington by Detectives from CUSI. After his arrest Detectives executed a search warrant on his residence.

During the investigation it was determined that Mr. Schunk sexual assaulted a female who he provided alcohol to and who was under the age of 21. Mr. Schunk was arrested for the crimes of aggravated sexual assault and furnishing alcohol to a minor. It should be noted that in 2003 Mr. Schunk was convicted for Prohibited acts and Sexual Assault victim <16 years. As a result Mr. Schunk is on the Vermont Sex Offender registry.

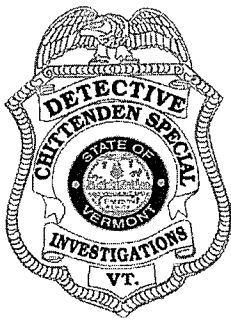
A person convicted of the crime of aggravated sexual assault in violation of Title 13 V.S.A. § 3253 shall be imprisoned not less than ten years and a maximum term of life, and, in addition, may be fined not more than \$50,000.00. A person who is convicted of furnishing alcohol to a minor in violation of Title 7 V.S.A. § 658 shall be fined not less than \$500.00 nor more than \$2,000.00 or imprisoned not more than two years, or both.

If you or someone you know has been a victim of sexual assault, there is support available. Even if the assault did not happen recently, there are resources to help you decide what is best for you, including free medical treatment, advocacy and support.
