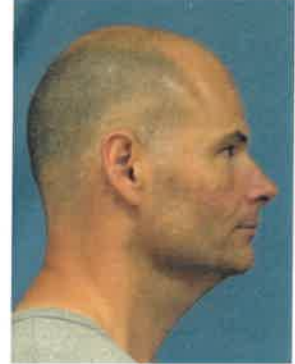
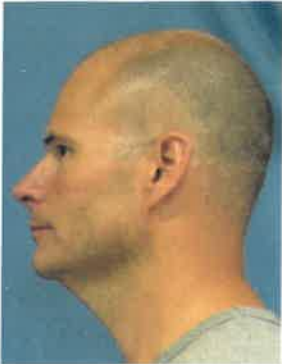

### SEX OFFENDER RELEASE NOTIFICATION

March 25<sup>th</sup>, 2019



**GREGORY J. GABERT (50yo)**

**Descriptors: 6'2"/ 250 pounds**

**Brown/Gray hair with Brown eyes**

On March 25<sup>th</sup>, 2019, Mr. Greg Gabert will be released after 30+ years of incarceration. Upon his release, Mr. Gabert plans to reside in South Burlington, VT where he will be under the supervision of the Vermont Department of Corrections-Burlington Probation and Parole. Mr. Gabert was incarcerated for the crimes of Lewd and Lascivious conduct, Assault & Robbery, Aggravated Assault and 2 counts of Sexual Assault. According to the Vermont Department of Corrections, Mr. Gabert has the following offense history:

**Lewd and Lascivious conduct:** On or about April-May 1986 Mr. Gabert sexually abused a 17-year-old female acquaintance.

**Assault & Robbery:** On 9/28/1986 Mr. Gabert assaulted and robbed a female at knifepoint threatening to kill her then taking her wallet.

**Sexual Assault:** On 9/29/1986 Mr. Gabert followed an unknown adult female college student to her dormitory pulling her out of her car while threatening to kill her. He then sexually assaulted her.

**Sexual Assault and Aggravated Assault:** On 2/10/1987, while released on bail and while on home confinement with his parents, Mr. Gabert went to a nearby neighborhood home. He entered the home under false pretense in order to steal a car. He found an 18-year-old acquaintance with her 18-year-old friend (unknown to Gabert) home alone. He physically assaulted both females and sexually assaulted the female whom he was acquainted. When he moved them into a vehicle the unknown female escaped to a neighbor's home and called Police. He drove off at high speeds and was quickly apprehended by law enforcement.

According to the Vermont Department of Corrections, compared to other incarcerated sex offenders, Mr. Gabert's risk to commit another sexual offense is considered to be in the High Category and his risk for general criminal recidivism is considered to be in the Moderate Category. Based on offender history, if Mr. Gabert were to sexually re-offend, his most likely victims would be adult females that are both known and strangers to him.

Mr. Gabert will also be listed on the Vermont Sex Offender Registry. Mr. Gabert has completed sex offender treatment and he will be released as compliant for the purpose of the registry. For further questions please contact Burlington Probation & Parole Phone at 802-863-7350.
