Re: Fitness Trail Sign Manufacturing and Installation

This Bid Request solicits shop drawings, fabrication and installation services for the installation of wayfinding signs throughout Burlington, VT's Parks System.

I. LOCATIONS

601 Lake St, Burlington, VT, Pause Places at the Urban Reserve

216 Leddy Park Rd, Burlington, VT, Leddy Park

96 Starr Farm Park Rd, Burlington, VT, Starr Farm Park

II. DESCRIPTION OF CURRENT CONDITIONS

In partnership with the *University of Vermont Medical Center* (UVMMC), BPRW installed three fitness stations along the recently renovated Burlington Greenway at Pause Places 1, 2, and 3. Additionally, this summer or fall two Pause Places with fitness stations are being constructed at Leddy and Starr Farm Parks. Construction at each of these sites is expected to begin in May and be completed by June 30. All of the locations receive frequent foot and bike traffic, particularly through the warmer seasons, which will make speed and scheduling of installation a priority.

The signage fabrication and installation will act as the finishing touch for each of these stations by providing basic information and wayfinding for Leddy Park and the Fitness Trail. Copy for these signs has been created and finalized by BPRW staff (see ATTACHMENT A).

The Pause Place and fitness stations consist of metal and plastic components mounted to an exposed aggregate concrete pad. The new signs will be mechanically fastened to the concrete pads with the exact location to be determined and field marked by BPRW and communicated to the selected contractor.

III. SCOPE OF WORK

- 1. Produce shop drawings for all signs and submit for BPRW Review
 - a. Drawings must be submitted and approved by BPRW prior to manufacturing
- 2. Manufacture all signs in accordance to material specifications and dimensions outlined in ATTACHMENT A
- 3. Add/Alternate: Provide a cost estimate for Installation of all signs
 - a. All signs are to be mounted to exposed aggregate concrete foundations provided by BPRW.
 - b. BPRW will mark final locations in the field prior to installation
 - c. BPRW will Dig Safe all locations in advance of installation
 - d. Contractor responsible for damage to any BPRW property and grounds
 - i. Any damaged areas shall be restored to their initial condition by the contractor
