## **NARRATIVE:**

On Sunday, October 27, 2019, at approximately 0233 hours, officers responded to reports of a fight in progress on the sidewalk and street in the vicinity of ESOX on Main Street, west of South Winooski Avenue. One participant fled, eluding officers, but officers stopped and identified two other persons of interest, Trevor Gaboriault, 21, and Casey Little, 22. Mr. Little stated he had not been fighting but had instead tried to prevent Mr. Gaboriault from fighting with another friend, whom he did not identify. Mr. Gaboriault, who had been struck on the head with a glass bottle, stated he did not know the other person. He was transported to the University of Vermont Medical Center emergency department by the Burlington Fire Department.

Several hours later, at approximately 0916, police were dispatched to Rose Street at Cedar Street where callers reported two males had entered their residence with a baseball bat and hammer. Upon officers' arrival, officers observed one male victim, 22, holding a white shirt to his head with noticeable blood on it. Residents advised the suspects had left the scene.

The victim's mother, 49, stated that she had heard banging on her front door. Upon opening the door, two males known to the victim's mother as acquaintances of the victim, Trevor Gaboriault, 21, and James Gaboriault, 26, allegedly pushed their way inside, yelling for her son. The victim's mother stated that her son had been involved in an altercation with these men almost two months

ago at the Champlain Valley Fair. The victim's mother called for help, and when the victim entered the room, Trevor Gaboriault allegedly struck the victim in the head with the hammer.

The men then fled in a black Subaru, which was identified by multiple witnesses, one of whom also knew the Gaboriaults.

The victim was evaluated on scene by BFD and transported to the UVMMC and treated for injuries to his head and arm.

Trevor Gaboriault was located and arrested in Colchester later that morning. James Gaboriault has not yet been arrested. Trevor Gaboriault was arraigned on Monday. A judge ordered that he be released into the custody of a responsible adult with conditions, among them not to possess dangerous weapons and not to have contact with the victim and the victim's mother. As no responsible adult was available in the morning, his case was to be recalled this afternoon.



The Burlington Police seek our neighbors' assistance with any additional information about these two incidents, which are believed to be related.
