CLARIFICATIONS: - The following information is offered to clarify project requirements:

1. The following is a clarification to scheduled completion of the project:

The contractor will be given a twenty-week window to substantially complete the project, ending on December 10, 2021. The project will be sequenced in three segments:

- **Austin Drive – SW corner of main parking lot.** Upper pavilion/restrooms, access to Cove beach, tennis courts, bocce courts, lower pavilion/restroom and Blanchard Beach remain open during this time [~4 weeks]
- **SW corner of main parking lot to west side of Lower Pavilion:** Access to upper pavilion/restrooms, Cove beach, tennis courts, bocce courts, lower pavilion/restroom and Blanchard beach remain open during this time [~4 weeks]
- **West Side of Lower Pavilion to 200' north of Flynn Ave:** Access to upper pavilion/restrooms, Cove beach, tennis courts, bocce courts remain open during ~[4 weeks]
- Final wear course of asphalt entire project [~2 weeks]
- Landscaping, shoulders, line striping, etc. [~2 weeks]
