Williams was arrested on Monday, January 10, 2022, arraigned in court the following day, and held without bail.	

On December 19, 2021 the Chittenden Unit for Special Investigations (CUSI) was referred a case from the Milton Police Department and the Vermont Department of Children & Families (DCF) regarding the alleged sexual abuse of a 12-year-old juvenile in 2019. The abuse was reportedly perpetrated by Alfonso Williams, 40, of Milton, VT.

The case was accepted by CUSI for further investigation in conjunction with DCF. That investigation subsequently resulted in the development of probable cause to believe that Williams committed the crime of Aggravated Sexual Assault on that juvenile victim.

On the afternoon of January 10, 2022, Investigators from CUSI with the assistance of the Milton Police Department arrested Alfonso Williams in Milton, VT without incident. Williams was subsequently processed and lodged at Northwest Correctional Facility on bail set by a Superior Court Judge.

On January 11, 2022, Alfonso Williams was arraigned and the court ordered him to be held without bail.

Alfonso Williams' criminal history includes criminal convictions for various crimes including violent felony convictions in both Connecticut and Vermont.

Aggravated sexual assault in violation of Title 13 V.S.A. § 3253(8)- A person who commits the crime of aggravated sexual assault shall be imprisoned for not less than 10 years with a maximum term of life, and, in addition, may be fined not more than \$50,000.00. The 10-year term of imprisonment required by this subsection shall be served and may not be suspended, deferred, or served as a supervised sentence. The defendant shall not be eligible for probation, parole, furlough, or any other type of early release until the expiration of the 5-year or 10-year term of imprisonment.

If you or someone you know has been a victim of sexual assault or domestic assault, there is support available.
