NARRATIVE:

On the afternoon of February 2nd, 2022, detectives from the Burlington Police Department and members of the BPD's Emergency Response Unit apprehended Jason Anderson, 45, of Burlington, VT, and Christine Terry, 38, of Burlington, VT, following a lengthy narcotics investigation.

Through the course of this investigation, Detectives also established Mr. Anderson as a Burglary suspect in addition to the narcotics distribution. Upon seeing police vehicles approaching him Mr. Anderson immediately fled on foot. After a brief foot pursuit, Mr. Anderson was taken into custody. Mr. Anderson's actions caused injuries to a BPD officer but they are believed to be minor at this time. Ms. Terry was taken into custody without incident

Mr. Anderson is facing several counts of methamphetamine sales, methamphetamine possession, burglary and aggravated assault. Mr. Anderson is currently on supervised release with Burlington Probation and Parole after he was convicted of several burglaries into occupied dwellings. Of note, Mr. Anderson was apprehended by Burlington Police in 2017 after he was interrupted by a homeowner while burglarizing a residence. During that burglary, Anderson pulled out a knife and threatened to stab the homeowner before fleeing. Anderson was detained at the Northwest State Regional Correctional Facility on a Violation of Parole pending a Parole Board hearing.

Ms. Terry is facing several counts of narcotics sales and possession. She was scheduled to appear in court on 2/3/22 but did not attend. Ms. Terry is now scheduled to appear in court on 2/27/22 at 2:00 PM.
