 - DAIL, AARP, etc. Statewide Survey Update KP (Kelly) Please continue promoting the survey through networks and posting on social media etc. Send mailing address to KP for postcards.
 - Data request update: (Jane, Marcella) Zip code level data from community needs assessment (DAIL, Agewell) requested to have Burlington level data – no update form DAIL, continue follow up.
 - Funding Request to City Council & Mayor: funding approved for city to hire intern in next FY – BAC to develop work plan.

BAC Leadership and organization – how to increase work and coordination between meetings. The Working Group model seems to provide direction to identify issues and make recommendations. Before initiating new working groups, wait for feedback from the ENVISION Vermont Age-Friendly Survey to inform next steps.

 - Healthcare Workforce Development (Jane). Working group has considered barriers, topics and made recommendations no further work at present.
 - Social Isolation/Inclusion (Glenn) group will meet 5/23 at 11.30am, GM will circulate invitation, all welcome to join.
 - Housing (Molly): Proposal to advance the Home Share Vermont Pilot Incentive Program (see notes) was approved by the Council (4/19). Advancing to Community Development and Neighborhood Revitalization Committee of City Council – focus on prevention based housing assistance to support aging in place, e.g. Homeshare- and expand SASH and other service type programs and home modification programs
 - UVM Capstone project groups (Glenn) Thanks to all See reports and recording on website, please review as they contain good practitioner learning and may inform new work focus areas.

KP noted that homelessness not considered in Working Group. Public Safety concerns were raised by neighbors in McKenzie House (A rental apartment community for seniors and people with disabilities). A member of the public joined the discussion and raised public safety concerns about the Transit Center.

JC – Please remember when considering senior housing that there is about \$90 million for housing in state budget - \$50 million for new units for people who are low income or homeless, \$20 million moderate income and \$20 million for Vermont HIP.
