- 4. Overview of Age Strong VT multisector Action Plan on Aging Well strategies and feedback. State of Vermont DAIL Adult Services Division Director Angela Smith-Dieng. See linked and attached presentation.

Does DAIL hold baseline data to measure outcomes? No baseline assessment but we have the age friendly VT survey results that provide a good baseline.

Any recommendations on achieving inputs from the public for the BTV plan? The focus groups and public listening sessions allowed the SoV to achieve input from a range of folks. Worth noting that the branding and social media campaigns brought in a lot of input from older Vermonters.

Where do we see commonalities and differences with the BTV proposal? Increase workforce participation – strong in BTV. Behavioral risk factor surveillance system – discussion on the availability of this system in BTV. Fight for justice – not in BTV plan but would be covered under accessing services.

Libby Tuttle presented the work to date on the working group reports and over-arching goals.

Ongoing work on ensuring that we have input and advocacy from under-represented groups – Libby/CEDO will conduct focus groups and seek additional input. Meeting with the City REIB Department for advice and input and will also seek input from CCRPC and City Planning Dept – (particularly for data assistance)

Discussion on the fact that the State Plan distinguishes between general older population and those with Alzheimer's Disease – BTV Plan does not address this.

Optimal health and wellness: concern raised at any recommendation for additional adult day centers. Current funding restrictions causing closures across the state, the current billing model does not allow for expanded services.
