Re: 702 Lake St (Urban Reserve Snow Storage)

Burlington Public Works and the Church Street Marketplace use the site at 702 Lake Street as a snow storage area for snow removed from the marketplace and streets of Burlington.

A nighttime operation of snow removal from the downtown happens approximately 4-6 times per winter and snow is removed from the Marketplace after every storm.

Noise in the area will be reduced with special instructions to the employees and the Marketplace contractor not to slam tailgates of dump trucks and driving slowly.

The area is clean every spring after the snow melts of any trash and debris.




