After subtracting these awards (totalling \$88,300) from the amount budgeted for FY93 for Burlington's Housing Trust Fund, \$14,700 remains. The Administrative Committee decided to await further information about construction costs for the Flynn Avenue Cooperative and further information about the alarm system for Women Helping Battered Women's emergency shelter. A decision on this final \$14,700 will be solicited by phone in the coming week.

Allocating the awarded \$88,300 among the special categories defined by the ordinance and resolution that established the Housing Trust Fund produces the following pattern:
