2. Old Business:

4. New Business:

a. Discussion of FY23 allocations:

- Director Pine explains increase in Housing Trust Funds:
 - Annual revenue increased from historic levels around \$200,000 to \$727,000

- Revenue sources are: increased dedicated tax, short-term rental tax, Inclusionary Zoning payments-in-lieu and conversion fee for condominiums that were rental units
- Director Pine explains there will be ongoing consideration of utilization of Housing Trust Fund monies, but no changes in funding recommendations for this time period
- Resumption of previous considerations of funding requests:
 - Councilor Hightower recommended \$7000 additional funding for Ethan Allen project by subtracting from \$300,000 City Place request
- Councilor Hightower moves to award Housing Trust Fund monies in the amount listed on the staff memo with an amendment of \$19,320.45 to Ethan Allen and \$293,000 to CityPlace projects.
- Erin Stoetzner seconds
 - Discussion:
 - Clarification from CEDO staff regarding funding amounts for aforementioned projects and total expenditures
 - Director Pine notes unfunded projects may receive future funding in the order listed
 - Question from Hayley Shriner regarding future listening sessions. Director Pine clarifies that feedback from lower-income homeowners would be sought and the how and when is outstanding.
