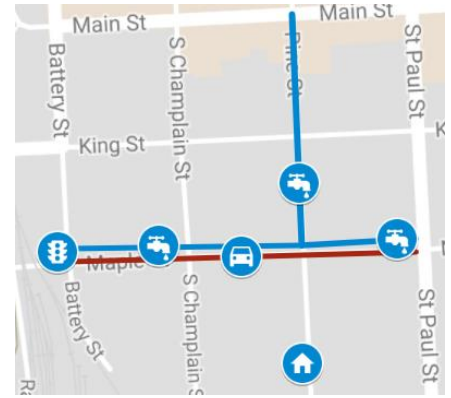

Construction Project Notice/ Invitation to Neighborhood Meeting



The City of Burlington is undertaking significant work to upgrade and invest in our aging municipal infrastructure. We thank you for your patience during these short term, but significant disruptions. These projects will lead to renewed and revitalized infrastructure that will serve you for a long time.

We are writing to let you know about a coordinated series of projects nearby, set to begin in April:

- **Water Main Upgrade: On Maple between Battery & St. Paul**
- **Water Main Upgrade: On Pine between Maple and Main**
- **Paving Work: On Maple between Battery & St. Paul**
- **Traffic signal and sidewalk work: At Maple & Battery**

Water Service, Traffic & Parking Impacts

- **Water:** If you live on Pine or Maple along the water main project, our contractor will need to install a temporary above ground water main with temporary water service to your home or business. This water line will provide you potable water as we work on the pipe. There will be some planned water service disruptions during construction. You will receive additional notification approximately 24 - 48 hours before planned water service disruptions.
- **Water:** Once construction begins, for any issues (24/7) related to the temporary water supply on Pine Street please contact SQUAREHAB at 802-495-6284. For all other water questions, please contact the Water Division (also 24/7) at 863-4501.
- **Traffic:** Construction zones will transition into local traffic only streets during most of construction. Detours will be established.
- **Parking:** Impacts along the construction routes and adjacent streets. We are proposing to regain some parking spots in other areas – to be decided at the March DPW Commission Meeting.
