NARRATIVE:

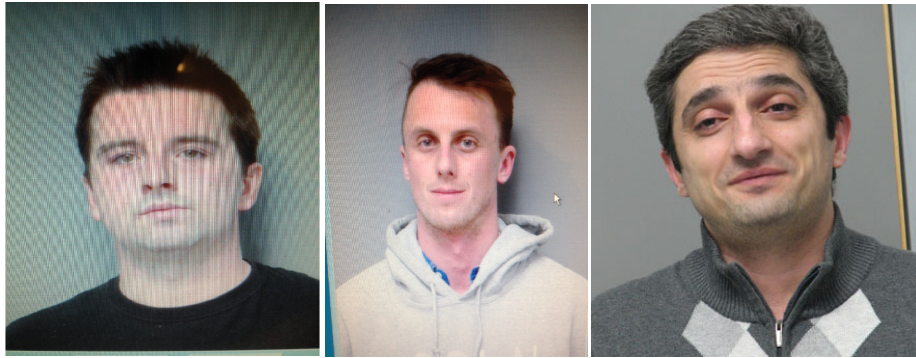

Ward was subsequently screened by a Drug Recognition Expert (DRE) and issued a citation to appear in court for DUI Drug.
