### NARRATIVE:

On 6-30-2014, at 1442 hours, police responded to a disturbance at the Bluebird Barbecue located at 317 Riverside Avenue in Burlington, Vermont. Upon arrival, it was learned that three subjects had entered the basement of the restaurant and were in the process of burglarizing the establishment when they were confronted by an employee. The suspects then assaulted the employee with a liquor bottle, which originated from the scene, and fled from the area. No other weapons were used or brandished during the assault.

The suspects were described as two black males, approximately 6'1-6'2" tall, with thin builds, approximately 17-19 years of age. The males were accompanied by a white female, approximately 17-19 years old, with dark wavy hair. The subjects rode dark colored bicycles to and from the scene.

## **UPDATE**

Burlington Police Detectives have been working on several leads as to the identity of those responsible for yesterday's burglary at the Bluebird Barbecue on Riverside Avenue.

At approximately 3:30 pm today (7/1/14) Burlington Police arrested Hasan Williams, a seventeen year Burlington resident. Williams was arrested for the following crimes; Burglary, Assault & Robbery, and Interference with Emergency Services. Williams is being charged as an adult and has been lodged at the Chittenden Regional Correctional Facilities. Williams' Bail was set at \$50,000.00.

Detectives are continuing to follow several leads as to the identity of the remaining two suspects and are still seeking anyone with any information relating to the incident or the suspects involved. ## **UPDATE July 2, 2014**

In connection to the ongoing burglary investigation at the Bluebird Barbecue Burlington Police Detectives have identified and arrested a second person. Due to the age of the individual their case has been referred to the Chittenden Family Division of the Vermont Superior Court; Family Division matters are confidential and their name and other identifying information cannot be released.
