- 3. Public Forum

Kathleen Kemp: Shares about supporting the work of the REIB Council Committee and committee meeting.

James Alvin Wakefield: Introduces himself and describes the impact of the work.

4. Welcome New Director

Kim Carson discusses her role as Director of REIB. Perri Freeman describes issues and policies that are important to Freeman's work. Asks how this committee can support the work of REIB. Carson describes that she will be moving to Vermont after Thanksgiving and how she will be moving the department forward.

5. Exploration of Creating a Commission

Dieng describes the differences between REIB committee and commission. Freeman agrees and describes how commissions can improve community engagement and bring ideas forward. Commissioner Grant agrees, and Hughes and Carson ask about the commission's roles. Rev Hughes introduces himself and discusses the idea of a commission and appointment. Discusses the development of REIB, the resolution, and VRJA's support. Dieng adds an agenda item for next meeting to bring at least 2 additional BIPOC organizations to discussion the creation of a commission.

6. Reparations Task Force update

Christine Hughes discusses the potential of adding Deacon Hill to the Reparations Task Force and Pablo Bose as chair. Working on a proposal for community engagement and setting up a space to give updates on the task force. Discusses scope of research and would like to connect with Kim Carson. Every Thursday night there is something scheduled at 6pm at the Richard Kemp Center centered on this topic. Next one is called, Slavery is Abolished, Next Steps... Carson describes the development for the history of black Iowans online course for teachers and the community members. Bor Yang has agreed to serve on the Reparations Task Force and her alternative will be Amanda Lucia Garces. Phet will send REIB resolution to Bor, Christine, and Kim.

7. REIB Department Updates

Phet Keomanyvanh discusses ARPA fund recipients, USCRI, VHEI, Spectrum, and USCRI. REIB allocated \$20,000 to VNAC on gun safety and gun violence and REIB has a staff member supporting this initiative. Discusses Dewey Park and bringing community members to support Call to Artists and to assess the best location for parks, however, there are some concerns about the sculpture, specifically location. Presented at NPA Wards 2&3 and are holding another community engagement event on December 5th from 5:30 – 6:30. Will share more details soon.
