SUSPECT DISPOSITION:

Suspect description: Caucasian male in his late teens or early twenties, between 5'11" and 6'2" with a thin build. The suspect had little or no facial hair and poor teeth. The suspect was wearing a dark coat with a blue or black hooded sweatshirt, royal/bright blue sneakers and a baseball style hat.

NARRATIVE:

On March 24, 2014 at 1801 hours, the Burlington Police Department investigated an aggravated assault at the Burlington Town Center located at 49 Church Street.

Upon arrival, officers met with multiple witnesses who advised the above-mentioned suspect displayed a handgun during an altercation with a group of males. No one was injured as a result of this incident. The suspect fled prior to the police arrival and his identity as of this time is not known.
