NARRATIVE:

On 04.27.15 at approximately 5:00 pm police responded to the area of the Rite Aid Pharmacy located at 1024 North Avenue for a report of a robbery that had just occurred. Officers were present in the area immediately and detained a person of interest a short distance away. A subsequent investigation developed probable cause that the individual detained, Bryan McMahon of Burlington, was the individual who had committed the robbery.

In the course of the robbery there were no weapons displayed though the presence of one was indicated. No injuries were reported, and McMahon initially made off with a quantity of opiates. All property belonging to Rite Aid has since been recovered. The immediate response of the pharmacy staff was key in the closure of this case; other potentially related cases are currently under investigation.

McMahon was lodged at the Chittenden Regional Correctional Facility for lack of \$100,000 bail and will appear in court on 04.28.15 to be arraigned on charges of Assault and Robbery. Assault and Robbery is a felony punishable by up to 15 years imprisonment.
