### NARRATIVE:

**On September 25, 2014 at approximately 2:40pm, the Burlington Police Department and Burlington Fire & Rescue responded to a motor vehicle crash involving a single vehicle and a pedestrian. The incident occurred in the area of Dealer.com located at 345 Pine Street in the area of a pedestrian crosswalk.**

**A 47 year old male pedestrian from Grand Isle County received on scene treatment from Burlington Fire & Rescue and would be transported to the Fletcher Allen Health Center for further treatment for non-life threatening injuries. The operator of the vehicle was identified as Kenneth P. Wrisley, 54 year male from Colchester, Vermont.**

**The initial incident required a temporary closure of Pine Street to allow for treatment of the pedestrian and the safety of other first responders who were on scene in the roadway. A preliminary investigation indicates that no other vehicles were involved.**
