Dismas of Vermont - Buell Street House - request for funding - Project Funding

RE: The Burlington Housing Trust Fund – Request for Proposals – Deadline Friday, September 30th, 2016

- 1. Burlington Dismas House (BDH) requests a grant consideration of up to \$12,000 for a project that would replace the failed sewer line from Buell Street Dismas House located at 96 Buell Street to the City of Burlington's line. If funded this project would allow us to continue operating un-interrupted and preserve ten (10) housing units for low income former prisoners. Over 600 men and women have lived at BDH since opening in 1986 and the program continues to play a vital role in helping former prisoners reintegrate into society.
- 2. This project is to be completed by the end of the current calendar year (2016). Cameras fed into the current sewer line from the house to the street documented that the line has suffered significant damage due to roots and age. The sewer line is probably the original system for the house and is made up of two foot sections of clay pipe. A solid mass of roots has grown into each joint of the sections of pipe resulting in a complete blockage that backed up into the basement three times in the last 18 months causing damage to floors as well as costly service calls. It has been routed out by a septic company creating a one inch opening thru the roots, but we were advised that this is a temporary fix at best. The project will include digging up the obsolete piping system and replacing it with pipe that meets current codes. Project proposal will include all required permits, repaving and repairing sidewalk if needed, repaving and repairing road if needed and any other external damage caused by the repair of the sewer line. Because there is a city tree that lies in the path of the line, costs will include laying the pipe to avoid any damage to the tree and its roots, thus preserving the tree.
- 3. The Mission of Burlington Dismas House (BDH) is to reconcile former prisoners with society and society with former prisoners. BDH provides structured, supportive transitional housing for men and women working to change their lives as they struggle to make the change from lives of crime and addition to lives as productive and contributing members of society. A successful stay at BDH reduces the repetition of criminal behavior and incarcation, and helps to reduce poverty and homelessness.

At BDH, affordable, safe, clean and sober housing is provided for former prisoners who work and pay weekly program fees and receive the basic human needs of food and shelter. When men and women are released from prison in Vermont, they often have no money for housing, have no employment, and frequently end up living on the street. Without basic shelter, they find it almost impossible to find employment or to receive help with addiction issues and nearly all former prisoners without basic shelter end up back in prison, usually within three months.

Without the completion of this repair, the current program and the ten (10) units provided could be in jeopardy. As an organization, two years ago Dismas underwent a rigorous capital need assessment, with the board recognizing the need to create a fund and plan to maintain the houses so to continue to provide the current level of support and units. In the last 12 months, the Buell Street House has spent \$10,000 on new flooring, both the front and back porch, and an interior staircase. While the capital needs assessment shows a level of responsibility and commitment, emergencies can have a severe negative impact on our ability to maintain and preserve the current units.

- 6. In regards to long-term affordability, bringing the sewer line up to current codes will alleviate the need for repairs and backup concerns for many years to come. That, coupled with the completed capital needs assessment, will help Dismas avoid a repeat of the current situation.
