BACKGROUND:

Peter A. Clavelle is a former mayor of Burlington and a 2004 candidate for Governor. Under his leadership, Burlington became a national model in sustainability, with emphasis on quality of life, high quality education for all, social equity, economic growth and development, and environmental health. His legacy includes eligibility of employee domestic partners in benefit coverage, and projects such as the Church Street Marketplace and Waterfront Development. Mayor Clavelle's vision led to the development of the Legacy Action Plan, Burlington's 2030 sustainability plan.

The plan is based on improvements in five areas related to sustainability: our neighborhoods, the economy, the environment, youth and life skills (including life-long learning), and governance. Taken together, the five major themes comprise Burlington’s Common Vision:

- Maintaining Burlington as a regional population, government, cultural, and economic center with livable wage jobs, full employment, social supports, and housing that matches job growth and family income
- Improving the quality of life in neighborhoods
- Increasing participation in community decision-making
- Providing youth with high-quality education and social supports, and lifelong learning opportunities for all
- Preserving environmental health

At our annual Town Meeting, participants identified social equity as a priority goal in each focus area.

The original plan was written in 1999 with input from hundreds of Burlington residents. It was ratified by the City Council in 2000 and included in the Municipal Development Plan. Mayor Clavelle appointed a project steering committee to oversee the public involvement campaign and prepare the Legacy Action Plan. Its members include thought leaders in business, low-income advocacy, environmental conservation, academic institutions, youth services and social service communities. Today, the steering committee continues to guide the renewal of the Plan through measurement of indicators in collaboration with the community.

ELIGIBILITY:

To be eligible to receive the Peter Clavelle Award, a person must be a professional who has led efforts that have advanced the sustainability of Burlington as described in the Legacy Action Plan, including work on social equity, economic growth and vitality, quality education for all, and/or environmental stewardship. Nominations for the award should include specific examples of accomplishment in any/all of the following areas:

1. Passionate, selfless commitment to improving the quality of life for all members of the Burlington community consistent with specific principles described in the Legacy Plan.
2. Recognition of events or trends which have advanced Burlington's progress towards becoming a sustainable community.
3. Identification and promotion of innovative solutions to advance any of the goals set out in the Legacy Strategic Plan leading to a sustainable community.
4. A record of mentoring and positive influence on others (elected or appointed officials or citizens; both children and adults) who have supported efforts that advanced the Legacy Plan.

THE NOMINATION PROCESS

Nominations should include a description of how the nominee meets or exceeds qualifications listed above with specific examples and supporting materials from the nominator or others. Links to supporting information on the Web may be included. Please provide a complete name, title, and contact information for the nominee. Please limit the nomination to no more than 2,000 words (not including supporting materials).

Nominations may be submitted by any person or group.
